Extract Resources is focused on developing the Husab open pit uranium mine in Namibia, the world's third largest known primary uranium deposit.

North River is focused on the exploration and development of resources in Namibia and Mozambique. Its principal focus is currently the re-opening of the Namib Lead-Zinc mine in Namibia, which is located close to the Husab project.

Qi Yu said "I am very pleased to be joining the Board of North River. This represents a good opportunity for us to build a successful business as part of the Kalahari group. We hope 2013 will prove an exciting year for the company."

Martin French, Executive Director of North River said "We are delighted to welcome Qi to the board as part of our new programme to strengthen and build the company. We have already built up a good working relationship with Qi during 2012, and this appointment cements that relationship. Qi brings a number of skills to the Board and will also act an important bridge between the company and Kalahari's extensive network of contacts in China and Namibia. This brings the Board membership up to five and we anticipate one further appointment in the near future."
